

## Certified Food Manager Requirement

City of North Richland Hills Ordinance 18-251 requires that all permitted food service establishments employ at least one certified food manager who has attended a certified food manager’s class approved by the Texas Department of State Health Services and who possesses a current North Richland Hills food manager registration, or who attends a certified food manager’s class certified by the American National Standards Institute (ANSI); a copy of this registration must be available on site at all times. The certified food manager must be employed on the premises of the establishment.
