Dear Mr. Hindman,

Please accept this letter as an Engagement Agreement for Consulting Services ("Engagement Agreement") describing the terms under which the VTruitt Consulting, LLC (VTC) will continue to provide consulting services to the City of North Richland Hills (NRH).

The term of this Engagement Agreement will be for twenty-four (24) months beginning October 11, 2020, and ending October 10, 2022. Either party to this Engagement Agreement may terminate this Engagement for any reason or no reason with 30 days written notice to the other party.

The consulting services provided by the VTruitt Consulting, LLC to NRH will be as follows:

- 1. Seek and share intelligence regarding potential legislation regarding issues related to municipal government as specified by NRH. VTC will report to NRH as indicated during the interim period when the Texas Legislature is not in session, and at least weekly, or more often, if needed, during the period of legislative session.
- 2. Track and analyze legislation regarding issues related to municipal government as specified by NRH.
- 3. Recommend action that representatives of the city may take to promote legislation that is favorable for residents of NRH, or dissuade legislation that is harmful to residents of NRH.

Consulting services provided pursuant to the terms of this Engagement Agreement will be at the retained rate of \$1,000.00 per month during the interim period when the Texas Legislature is not in session, and \$1,200.00 per month during the period of a legislative session. In addition to the monthly retainer, NRH shall reimburse VTC for all expenses associated with services provided under this Engagement Agreement, including but not limited to, mileage, parking, toll road fees, and all other travel expense, hotel/overnight stay, entertainment of clients, meals, etc., if required. VTC shall seek pre-authorization for expenditures in excess of a mutually agreed upon amount prior to incurring expenses on behalf of NRH.

VTC shall send a statement to NRH for the monthly retainer and any expenses incurred, including any and all receipts related to expenses made on behalf NRH, if any. Payment is due and payable upon receipt, but no later than 30 days within receipt of invoice.
